L-ISKEMA tidhol fis-sehħ fl-1 ta' Jannar, 2025, u tibqa' fis-sehħ sal-31 ta' Diċembru, 2025, sakemm ma tigix modifikata jew mitmuma minn qabel b'Avviż fil-Gazzetta tal-Gvern. Din l-iskema, li għandha taħseb biss għall-applikazzjonijiet li rċeviet Transport Malta li ma setgħux jibbenefikaw mill-iskema simili li kienet fis-sehħ fl-2022, għandha titqies bħala mitmuma meta l-baġit allokat jiġi eżawrit. Minkejja dan, il-Gvern jista' jtemm l-iskema f'kull żmien billi jagħti avviż minn qabel.

THE scheme will enter into force on the 1st of January, 2025, and will remain in force until 31st December 2025, unless modified or terminated beforehand by a Notice in the Government Gazette. This scheme, which shall only cater for applications received by Transport Malta that could not benefit from the similar scheme that was in place in 2022, shall be considered as terminated when the allocated budget is exhausted. Notwithstanding, Government may terminate the scheme at any time by giving prior notice.

In terms of the provisions of paragraph 9 of the Government Notice No. 1746 published in the Government Gazette No. 20,980 dated 23rd December, 2022, the Minister for Transport, Infrastructure and Public Works is making the following amendments to the Scheme:
